DID YOU KNOW the cost of a Children's Advocacy Center (CAC) multidisciplinary investigation is approximately \$1,000 less than the cost of a non-CAC child abuse investigation on a case-by-case basis?

The Gingerbread House has served 10,897 child victims (as of June 30, 2018) since opening its doors 20 years ago.

By this conservative estimate alone, the Gingerbread House has saved the northwest Louisiana community over \$10.9 MILLION since opening its doors in June, 1998!



1,213 children received forensic interviews, multidisciplinary team investigations, child life and family advocacy services. In August 2018, our busiest month to date, we served 107 children.


285 child victims and their non-offending caregivers received counseling services.

"Before Gingerbread House was formed in 1998, abused children would often be subjected to multiple interviews, often 5-8 interviews, by law enforcement, child protective services, and others. These interviews would take place at the police or sheriff's stations, typically in very sterile and plain environments that were not child-friendly in the least. As a result, less than 5% of cases were being successfully prosecuted. We knew there had to be a better way, so we looked at national models and best practices, and moved forward with establishing the Gingerbread House Children's Advocacy Center. Currently, over 97% of cases accepted for prosecution are successfully prosecuted. What was once a dream...helping children who had been hurt...has indeed become a reality through the Gingerbread House."
